- (a) You are deployed in a Temporary Change of Station (TCS) status. This is not a Permanent Change of Station (PCS). Normal PCS entitlements allowances and relocation of family members is not authorized.
- (b) Unit members will travel as a group.
- (c) Movement Designator Codes: PM03- (NOTE: The MDC "PM" used will ensure that soldiers remain in the parent unit for strength accounting at the PERSCOM LEVEL). Failing to use MDC "PM" makes the departure look like PCS and soldiers will be assigned to the TCS location.
- (d) During period of deployment, home station commander has responsibility for personnel service support to include awards and decorations, personnel strength accounting, promotions, and all other forms of personnel support except reserve component promotion authority.
- (e) Temporary storage of HHG/POV may be authorized, IAW JFTR PARA U4770.B, for geographical bachelors and single soldiers authorized by the commander to reside off post. Soldiers must submit a request through the chain of command to the Installation Transportation Office for approval. Contact local transportation office for assistance.
- (f) Travel by POV not authorized.
- (g) Transportation of personal weapon is not authorized unless directed in movement order.
- (h) You will bring only those items specified by Commander, PERSCOM/FORCOM or other appropriate authority.

- (i) Soldier Readiness Processing (SRP) will be accomplished prior to departure from losing installation / home station per AR 600-8-101, Chapter 3 and 4. You will hand-carry your deployment packet and verification of SRP.
- (j) Government quarters and meals are directed if available.
- (k) For active duty soldiers, including active guard/reserve, Basic Allowance for Housing (BAH) is based upon their permanent duty station. For reserves and retired members ordered to active duty for more than 139 days in support of the operation, BAH is based on their permanent place of residence when ordered to active duty if denied movement of dependents and HHG.
- (l) Soldier may submit interim travel voucher if otherwise entitled to per diem and/or travel. Soldier is advised to keep all required documents to support payments/request for payments.
- (m) For unit deployment, BNS! or other MILPER element, must submit a unit deployment (UDPL) transaction with DPLI CODE "B". Leave estimated return blank. SIDPERS-3 sites submit country codes. SIDPERS departure transaction will not be submitted for soldiers deploying as part of a unit.
- (n) Soldiers are authorized \$2.00 (two dollars) per day for incidental expenses in CONUS and \$3.50 (three dollars and fifty cents) per day for incidental expenses in Theater of Operations, where government quarters and meals are available they are to be used, Commanders are to issue "statement of" where rations and quarters are not provided.
- (o) Family Separation Allowance II (FSA-II) are paid to soldiers with dependents that are TDY outside of the United States for more than 30 days. Enlisted soldiers may be entitled to Hardship Duty Pay for Location (HDP-L). Soldiers are entitled to Basic Allowance for Subsistence (BAS).
- (p) Excess baggage authorized not to exceed 2 pieces of 70 lbs each to include individual weapon.
- (q) Reserve Component (RC) physicians (MC), Dentists (DC) and Nurse Anesthetists (CRNA) will be involuntarily mobilized in their current grade and employed or deployed for 90-days in a theater of operations (Boots-on-the-Ground (BOG)) exclusive of any required pre-and-post deployment periods in concert with operational requirements.
- (r) Unit is attached to Fort Dix for command and control, administration, logistical support and the administration of Uniform Code of Military Justice while at the MOB Station.
- (s) Travel variations authorized.
